**I. CALL TO ORDER**

**11. READING OF MINUTES FROM JANUARY 21, 2010 MEETING**

**V. PROPOSAL TO MODIFY BY LAWS 9.D AND 9 E.**

Joan Sheldon made a motion to add an "extenuating circumstances" clause to the following BY LAW.

**ARTICLE 9. D PROPOSAL**

President Cup will be open to members having 12 credited league days prior to September 1, will be played to full handicap and will be scheduled after September 1. In case of extenuating circumstances that prevent a member from completing the 12 required rounds, that member may petition the Board for an exemption. The Board's decision will be final.

Sandy Blaise seconded the motion and it was APPROVED by the membership.

Joan Sheldon made a motion to add an "extenuating circumstances" clause to the following BY LAW.

**ARTICLE 9.E PROPOSAL**

Club Championship will be open to members having 12 credited league days prior to October1; will be a gross tournament played in flight, except the Championship flight which is open to all members, and will be the last tournament of the year. In case of extenuating circumstances that prevent a member from completing the 12 required rounds, that member may petition the Board for an exemption. The Board's decision will be final.

The proposal was seconded by Pat D'Amato and APPROVED by the membership.

**V1. NEW BUSINESS**

The following resolution was presented by Debbie Massie:

**BE IT SO RESOLVED**, we, the Tradition Ladies Golf Association, do award and acknowledge Joan Sheldon as our 2010 Honorary Club Champion. **BE IT FURTHER RESOLVED**, we, The Tradition Ladies Golf Association, request Joan Sheldon to represent our league at the annual South Carolina Golf Association Club Champions Tournament as our 2010 Club Champion.

After hearing the resolution , the majority of the league members present stood and applauded. Joan graciously accepted the acknowledgment.

Dani Jennings presented a proposal to amend the TLGA Local Rule regarding Blue Tee Play. The proposal is to eliminate the "age 70" qualification and base qualification for Blue Tee Play on handicap index only.

**PROPOSED:** Blue Tee play is voluntary and is allowed for any TLGA Member who has a 36.4 or higher Handicap Index from the Red Tees. The member must have completed at least one (1) year of league play from the Red Tees.

The PROPOSAL did NOT pass.

With no further business Maureen Lempert made the motion to adjoun and the motion was seconded by Nancy Malara and APPROVED by the membership. Meeting was adjourned at 10:50 AM.
